

Someone will be there to met and greet you. We will then take you through some house rules and show you how to lock up. After, the place is yours and we leave you to enjoy your day!






AFTER







TERMS AND CONDITIONS

1.0 Booking Procedure

1.1 No booking will be deemed confirmed until we have received:

1.2 A signed copy of the Venue Hire Terms & Conditions acknowledging that the client has accepted them and 50% deposit of total booking.

1.3 The non-refundable deposit of 50%

1.4 The balance of the booking fee is due to secure your booking.

1.5 **Bond**

1.6 A bond is required and will be released 24hrs after your departure providing no damage to property.

2.0 Cancellations

2.1 All payments to Casa LéRose in respect of a venue hire are **non refundable** and will be transferred to a cancellation fee in the Event of a full or partial cancellation or postponement.

2.2 If a confirmed booking is postponed, transfer of the deposit against cancellation fees may be agreed upon at the sole discretion of Casa LéRose.

2.3 Casa LéRose properly and reasonably reserves the right to cancel or terminate wholly or in part any booking at any time for any reason including but not limited to the following:

2.4 If the client becomes bankrupt or insolvent or enters into liquidation or receive-ship.2.5 If the client is more than 14 days in arrears in respect t of payments due to the Venue in respect of pervious or current bookings or parts thereof.

2.6 If the behaviour of the Client or Guests (whether as individuals or as a group) is deemed by the Venue to be unacceptable. Partial termination could result in a number of Guests being asked to leave the Venue.

3.0 Venue Access

Casa LéRose is a space which at times will be used by more than one person on the same day. 3.1 The client must arrive and vacate at the agreed time, as stated on the Venue Hire Agreement. Failure to adhere to the agreed times may incur additional chargers. In the event of unauthorised overrunning the Venue withholds the right to interrupt the shoot with or without the assistance of security.

4.0 Client's Responsibility

4.1 The client and their guests are damage to Venue furniture and ed will be charged to the client.
4.2 Any costs incurred by Casa Léft terms and conditions of the Venue not limited to: overrunning of the liglassware, furniture etc - will be inventoried and may not be transfunder the Venue Hire Agreement.

4.1 The client and their guests are responsible for wilful or negligent loss and/or damage to Venue furniture and equipment. Any costs of making good any damage will be charged to the client.

4.2 Any costs incurred by Casa LéRose due to failure by the client to adhere to the terms and conditions of the Venue Hire or the Venue Hire Agreement - including but not limited to: overrunning of the hire, requirement of additional cutely, crockery, glassware, furniture etc - will be invoiced to the client.

4.3 All furniture and equipment including cutlery, crockery and glassware has been inventoried and may not be transferred to any other area other than the area hired under the Venue Hire Agreement.


